2009 Event Dates

- July 4th, Saturday – Practice
- July 5th, Sunday – Qualifying and Tandem Battles

2009 Registration and Entry Fees

- \$350.00 SGD (For all competitors)

Payment details to be provided only when driver approval has been formally granted by Binter. Drivers will be notified of the status of their application by June 10th. All competitors are recommended to use Goodyear tires. Privateer and non-sponsored competitors will be provided with special rates for tire purchase of above brands. Please contact Binter for tire purchase at least 30 days in advance of the competition.

Each driver will receive 2 passes for pit crew listed on the registration form. These passes will not allow the holder to gain “hot” area access. Additional crew passes will be made available at \$25 SGD per pass.

One registration application per car must be submitted to be officially confirmed entry for Formula Drift competition. If a registration application is not submitted, the team will not be eligible for competition and will not be included on entry lists or press materials.

It is the responsibility of the team/driver's to meet all deadlines without notice from Formula Drift. Failure to do so will result in fines and/or forfeiture of registration for the event. Entry fees must be received by the close of business (5:00pm) on the date of the specified deadlines. If entry fee is received after deadline either a \$100.00 SGD fee will be charged in addition to the entry fee, or driver will forfeit his/her spot reserved for the event. There is no on-site registration.

1. Credentials & Licensing

Formula Drift will manage all transactions for credentials and registration. This will include on-site credential pick-up and registration. Drivers/teams are responsible for property registering all essential team members.

Participants holding a Formula Drift credential will need to sign a liability release waiver upon receiving the credential at the event.

Formula Drift credentials should be used for drivers and crew support members that will be attending the event. All registered drivers must submit a head shot photo to be printed on the credential. A digital JPEG headshot file (minimum of 100kb) must be emailed to Formula Drift.

2. Refund Policy

A. Per Race Entries:

A 50% refund will be granted if a formal request is received, in writing, to the Formula Drift office at least 20 days prior to the event date. This is to allow adequate time to redo pit spacing for the event.

B. Transferred Entries:

There will only be no roll over or transfer of an entry. Entries will only be for current 2009 Singapore Championship.

3. Team Paddock Space

All Formula Drift teams will be guaranteed a paddock space. Teams bringing rigs or trailers for paddock space must notify Formula Drift. All rigs and trailers in the paddock must be presentable. Any additional space needed may be subject to additional charges.

Teams are not allowed to put up any banners or other forms of signage without the pre-approval of ESPN STAR SPORTS.

Teams are not allowed to give away or sell any form of products or merchandise without the pre-approval of ESPN STAR SPORTS.

4. Prizes

Prize money and other forms of sponsored prizes will not be issued unless this form is completed in full including the passport/ ID number of the driver. One form per car must be filled out and on file with Binter. Prizes will be mailed by Binter to the company/person designated. Prize money that remains unclaimed 3 months after the date of the event will be forfeited.

Please note that \$200 of each application fee will be allocated into a common prize pool. The prize breakdown is as follows:

1st Placing:	50% of Prize Pool
2nd Placing:	30% of Prize Pool
3th Placing:	20% of Prize Pool

Accumulated prize pool is dependent on number of participating drivers.

5. Decal Placement

A Decal Placement sheet is included in Appendix D of the Formula Drift Singapore Rules and Regulations booklet. All cars will be provided with complete official Formula Drift and Sponsor decal set. A picture of the car is to be emailed to organizers for review. **There will be no decal restrictions imposed by the organizers for on-car decals.**

6. Attire

All drivers are to be fully suited at all Formula Drift meetings during the event duration.

7. Rules and Regulation

All drivers and crew members are required to review all contents of the "Formula Drift Pro-Am Rules and Regulation booklet".
